EXHIBITOR MANUAL WILL BE MAILED ON RECEIPT OF THIS CONTRACT

General Conditions for Exhibitors

- In these conditions the term "Exhibitor" means the signatory of this application, and includes all employees or agents of such and the term "Exhibition" means that described on the reverse hereof. "The Organizer" means TRADEXPO International
- 2. In case of joint venture howsoever described, the Exhibitor is deemed to have obtained the consent of all the individual participants to all the conditions of this contract.
- 3. If the Exhibitor does not pay the balance of the contract price at the prescribed time, the Organizer reserves the right after due notice to the Exhibitor or the agents as appropriate to cancel the booking. In this event, or if the Exhibitor cancels the booking after the application is granted, the deposit will be forfeited. Additionally, if cancellation occurs for either reason after the prescribed date for payment of the balance of the contract price, a sum in liquidated damages equivalent thereto will be payable by the Exhibitor to the Organizer in any event.
- 4. Application for space must contain details of the proposed exhibits and the name of any other company represented by the Exhibitor whose products are to be shown on or whose services are to be referred to on the stand. The charge for space is exclusive of any applicable federal or local Government or Municipal tax all of which if any must be borne by the Exhibitor. Currently no such taxes are levied.
- 5. The Organizer shall have full power to determine in every respect the allocation of area and position of space and it shall be entitled for any reason which in its sole opinion is in the general interest of the Exhibition to vary the general layout or the situation and area of any particular stand even if already allocated and the Exhibitor shall accept a new allotment of space in substitution of that originally allotted.
- 6. Upon the acceptance of the Application for space a contract shall arise between the Organizer and the Exhibitor in the terms of these conditions subject to variation as mentioned and as regards space allotted the relationship of licenser and licensee shall immediately arise and continue between the Organizer and the Exhibitor. In case of non payment of any sum due or any breach or non-observance of any of these conditions by the Exhibitor, the Organizer shall have the full right to revoke this license and to re-enter upon the allotted space and may remove and exclude the Exhibitor without prejudice to recovering all monies payable thereunder, all other claims against the Exhibitors and the right to recover damages sustained by the Organizer.
- 7. The Exhibitor shall occupy the space allotted to it by 8AM on the day prior to the opening of the Exhibition. In the event of default due to any cause whatsoever the Exhibitor shall pay to the Organizer a further sum in liquidated damages equal to the total charge of the space and the Organizer shall have the right to deal with the space in any way it thinks best.
- 8. In the event of any Exhibitor committing an act of bankruptcy or if a limited company being wound up the contract with it shall be determined void and all monies already paid shall be retained by the Organizer.
- 9. The Exhibitor may not assign, sublet or grant licenses in respect of any part of the space allotted to it nor may advertisements of firms who are not bonafide exhibitors show on its stand. Only those products, services and companies mentioned on the application form may be incorporated in the stand.
- 10. **Breach of Contract and Withdrawal by the Exhibitor:** Without prejudice to the rights and remedies of the organizer in respect of any breach of the Contract on the part of the Exhibitor, the Organizer may at its discretion allow the exhibitor to withdraw from the Exhibition subject to the following conditions:
 - The Exhibitor must give written notice to the Organizer that he desires to withdraw and if the Organizer allows such withdrawal it will notify the Exhibitor of
 its decision in writing;
 - ii Any such notification by the Organizer to the Exhibitor will constitute a cancellation of the Contract subject to the payment by the Exhibitor to the Organizer of a consideration for release from the Contract;
 - iii The amount of such payment will be specified in the Organizer's notification to the Exhibitor and will be that proportion of the space rental payable under the contact dependent upon which the organizer receives the notification from the Exhibitor as detailed below:

Date of Receipt by Organiser of Notice of Withdrawal	Proportion of space rent payable
On or before 30 th March 2023	50%
After 30 th March 2023	100%

- iv. Upon payment of such amount to the Organizer by the Exhibitor (credit being given by the Organizer for all rental already paid by the Exhibitor) the Contract shall be canceled and neither party shall have any further claim against the other.
- 11. The Exhibitor will be totally responsible for the cost of restoring its original condition any part of the stand or structure occupied by it which has been altered or damaged in any way.
- 12. The Organizer shall not be responsible for the loss or damage to any property of the Exhibitor or any other person caused by theft, fire, defect in the Trade Center Exhibition Hall ("the Hall"), storm, tempest, lightning, national emergency, civil unrest, war, labour disputes, lockouts, explosions, Acts of God and general cases of force majeure whether or not ejusdem generis with the foregoing or any cause not within the Organizer's control or for any loss or damage sustained in the event that the opening or holding of the Exhibition is prevented, postponed or abandoned or if the Hall becomes totally or partially unavailable for the holding of the Exhibition due to any of the foregoing causes. The Exhibitor shall indemnify and hold the Organizer safe and harmless from all loss and damage to person or property and all claims arising out of the Exhibitor's stand fittings and for the Exhibitor is advised to take out insurance cover for the purpose of indemnifying the Organizer as aforesaid and also to cover itself against all risks in respect of which the Organizer is expressed not to be responsible in these conditions.
- 13. In no event shall the Exhibitor have any claim for damages of any kind against the Organizer in respect of any loss or damage consequent upon the prevention or postponement or abandonment of the Exhibition by reason of the happening of any of the events referred to in Condition 12 or otherwise or of the Hall becoming wholly or partially unavailable for the holding of the Exhibition for reason beyond the Organizer's control and the Organizer shall be entitled to retain all sums paid by the Exhibitor or such part thereof as the Organizer shall consider necessary. If in the opinion of the Organizer by re-arrangement or postponement of the period of the Exhibition or by substitution of another hall, or building or in any other reasonable manner, the Exhibition can be carried out these Conditions shall be binding upon the parties except as to size and position as to which any modification or re-arrangement shall be determined by the Organizer.
- 14. The Exhibitor shall hold the Organizer safe and harmless from all loss or damage suffered by or arising out of any act or default of any servant agent employee or subcontractor of the Exhibitor.
- 15. The Organizer reserves the right to alter, add to, or amend any of these Conditions and the decision of the Organizer shall be final.
- 16. The Exhibitor shall not without the written consent of the Organizer display, exhibit or bring into the Hall any explosives or dangerous material or any such thing which cause noxious fumes or which make use of or display any other materials which may involve a danger to the health or safety of any person. The Exhibitor shall indemnify the Organizer against any loss or damage arising out of a breach of this clause.
- 17. An Exhibitor's Manual will be issued to the Exhibitor containing detailed instructions for the organization of the Exhibition.
- 18. The Organizer cannot accept any complaint or claim against it unless it is submitted in writing to the address given below within two weeks of the closing date of the Exhibition. All claims and disputes shall be settled in Dubai in accordance with Dubai Law and customs.
- 19. All display advertising exhibits and stand arrangements shall be appropriate to the subject matter of the Exhibition in the sole opinion of the Organizer and shall be tasteful and of a suitably high standard and shall not contravene or conflict with any local law, moral or custom and if in the opinion of the Organizer, the Exhibitor is in breach of this clause, the Organizer may direct the Exhibitor to rectify such breach and the Exhibitor shall immediately act accordingly.
- 20. In the event of a breach of any of the conditions herein the Organizer may in all cases retain all monies paid by the Exhibitor and recover further monies from the Exhibitor as provided herein.
- 21. Stand rentals may be paid in US Dollars, HK Dollars or UAE Dirhams. The Exhibitors is liable for making good any exchange losses to the Organizer at the time of conversion into Dirhams. All communications to be addressed to:
